This is the broadest range of network providers and Internet Exchanges with the largest aggregated traffic volume of any data centre operator in Europe.

Other core considerations were maximum uptime, redundant power and cooling, robust security, and round-the-clock access to equipment. Interxion delivered on all of these fronts. An added bonus was that the Interxion Stockholm data centre is located in Kista, where Cloudmore has its headquarters.
